SABS System Certification minimum height

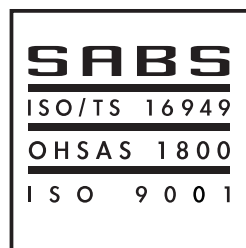
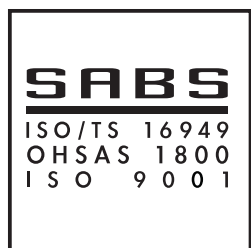
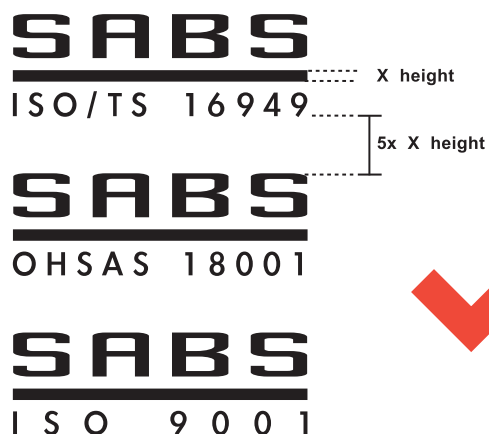

- The Multiple System Certification device must be applied where more than one certification is relevant.
- Individual System Certifications are arranged on top of another, taking into account the Multiple Certification Device measuring system.
